

## LICENSE FOR ONLINE MUSIC USAGE

### Description:

The music enhances the website or online offer, but it is not the main content of the site or offer. Website visitors may only listen to the music content (streaming) free of charge.

Applicable for usage of audiovisual reports, clips etc. that contain music works, as well as musical intros and background music on websites (music starts playing automatically upon loading of the page), media libraries, music in online games and the offer of a few selected musical works for on demand streaming.

### Royalty fees AKM and austro mechana (excl. VAT):

The applicable royalty fee is the greater of a percentage of the net revenue (revenue excl. VAT; e.g. from advertisements, sponsoring etc.) generated by the website or the applicable minimum.

AKM and austro mechana's percentage share is:

\* Website visitors per month means the aggregate number of unique visitors (unique clients) per month that access the site where the musical content is offered.

### **Small Scale License:**

For websites and online offers with limited music usage that do not generate more than **EUR 2.500** revenue (excl. VAT) per month, Small Scale Licenses based on the minima according to page 1 can be obtained in our online license shop at [www.akm.at](http://www.akm.at).

In case your online music offer exceeds the aforementioned parameters for Small Scale Licenses, please get in touch with your contact person for online licensing at AKM and austro mechana to obtain your license agreement.

### **Additional information:**

For licensing online uses of music, licenses from both AKM and austro mechana are required.

All fees are exclusive of VAT.
